This following document sets forth the Privacy Policy for the use of the Matsuri in Sydney Incorporated website (<http://matsurisydney.com>).

Collection of your personal information

This collected information is used solely internally for the purpose of gauging visitor traffic, trends and delivering personalized content to you while you are at this Site.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future we will use for these new purposes only, data collected from the time of the policy change forward will adhere to our updated practices.
